

5 **Daa'imman Koolugaltummaa Nama Hin Qabne**

Yoo koolu galtummaa gaafachuuf UK dhuftu umuriin kee 18 gadi yoo ta'e daftee dubbachuun jechuun kee baay'ee barbaachisaadha. Jalqaba waraqaa irratti umurii kee akka akeektu si gaafatama.

Akka seera UKtti namni umuriin isaa waggaa 18 gadi ta'e akka daa'imaatti kan ilaalamu yoo ta'u, deeggarsa adda addaa argata. Yoo umuriin kee 18 gadi, fi warra kee ykn nama guddaa si kunuunsu malee UK dhufte, akka "mucaa koolu galtummaa nama waliin hin deemneetti" ilaalama.

 **Madaallii Umurii Jalqabaa**

IWajjirri Biyya Keessaa umuriin kee 17 fi isaa gadi yoo ta'e, sana booda 'Madaallii Umurii Jalqabaa' kan gaaffii fi deebii gabaabaa ta'e ni raawwatu. Kun akka idileetti naannoo daqiiqaa 40 fudhata .

Akkaataa ati fakkaattee fi akkaataa ati itti amala qabdu fi deebii ati gaaffilee tokko tokkoof kennitu irratti hundaa'uun daa'ima umuriin kee hin geenye ta'uu kee ni murteessu. Kun erga dhuftee yeroo muraasa booda waan ta'uuf baay'ee dadhabuu dandeessa. Kanaaf qophaa'uun gaariidha.

Gaaffii akkamii gaafachuu danda'u? 

Gaaffii fi deebii gabaabaa kana keessatti umriin keessan meeqa akka ta'e isin gaafatama. Akkasumas waa'ee imala keessanii, umriin keessan meeqa akka ta'e akka beektuu fi maaliif gara UK akka dhuftan gaaffiin isin gaafatama.

Guyyaa dhaloota kee HIN tilmaamiin – kun baay'ee barbaachisaa dha. Guyyaa sirrii itti dhalatte yoo hin beekne, umurii kee akka ta'e maaliif akka beektu ibsi. Si gaafatamuu danda'a:

- Guyyaa dhalootaa FI umrii kee
- Yeroo biyya kee baate umriin kee meeqa ture fkn. Bara darbe Ramadaana booda qofa yeroon umuriin koo waggaa 15 ture biyya koo ba'een ture kanaaf amma umuriin koo waggaa 16 ta'eera.
- Yeroo mana barumsaa baate umriin kee meeqa ture
- Obboleeyyan kee umriin isaanii meeqa fkn. Obboleessa waggaa lama na caalu qaba kan dhiheenya kana waggaa 18 guute kanaaf umuriin koo waggaa 16 akkan ta'e nan beeka.
- yaaddoo fayyaa qaamaa ykn sammuu yoo qabaatte ykn
- Biyya kamittuu karaa irra jirtu akka Xaaliyaanii ykn Faransaayitti akka daa'ima umriin isaa hin geenyeetti yoo si ilaalame waa'ee kanaa dubbachuu dandeessa.

Akkasumas, qondaaltota gaaffii fi deebii kanaa fi gaaffii fi deebii sakatta'iinsaa keessan gaggeessan, yoo fira UK keessa jiraatan, yoo isaan waliin jiraachuuf yaaluuf hin karoorfanne ta'ellee itti himuun barbaachisaa dha.

Ragaa qabaachuu qabdaa?



Ragaa umurii keessanii kan akka paaspoortii, waraqaa eenyummaa ykn ragaa dhalootaa, orjinaala ykn kooppii yoo qabaattan, kana daftee qondaaltotatti himuu qabda. Sanadni tokko yeroo hunda madaallii umurii jalqabaa irratti umurii kee mirkaneessuuf gahaa miti. Yeroo tokko tokko namoonni kana akka agarsiisan hin hayyamamu, garuu boodarra 'madaallii umurii' jalqabaa irratti nama guddaa ta'uun kee yoo argame dhimma keetif faayidaa qabaachuu danda'a.

Umurii kee fudhachuu isaanii akkamitti beekta?



Kunis gaaffii koolugaltummaa keessaniif baay'ee barbaachisaa ta'uu danda'a. Sababiin isaas daa'immanis mirga koolugaltummaa gaafachuu waan qabaniif. Madaallii umurii jalqabaa booda Waajjirri Biyya Keessaa ni murteessa .

1. Isaan ati nama xiqqaa ta'uu kee amanuu YKN
2. Nama guddaa (18 ol) akka taate sitti fakkaata .
3. Odeeffannoo dabalataa isaan barbaachisa.

Yoo umuriin kee 18 gadi ta'uu kee amanan YKN odeeffannoo dabalataa akka isaan barbaachisu amanan gara bakka jireenyaa ijoollee biroo wajjin jiraattutti ni deemta. Itti fuftee madaallii umurii dheeraa kan biraa gochuu dandeessa. Bakki jireenyaa kun UK keessatti bakka kamiyyuu ta'uu danda'a.

Yoo umuriin kee 18 gadi ta'uu kee hin fudhanne gara bakka jireenyaa ga'eessota waliin si erganii akka nama guddaattis si ilaalu.

Waajjirri Biyya Keessaa yoo umuriin kee 18 gadi ta'uu kee hin fudhanne maal gochuu dandeessa?



Hojjetoota bakka jireenyaa GA'OOTA kanaatti akka ati umuriin kee 18 gadi ta'e, doktora ykn narsii, fi dhaabbilee ati waliin hojjettu kamiyyuu daftee daa'ima ta'uu kee itti himuu qabda. Gargaarsa Godaantootaas beeksisuu qabdu. Akka isaan gara bulchiinsa naannootti si erganiif ykn madaallii umuriidhaaf hojjetaa hawaasummaa arguu akka barbaaddu gaafachuu qabda.

Akkasumas Humans for Rights Network qunnamuu qabdu kana irratti si gargaaruu danda'a 00447506663089 irrattis qunnamuu dandeessa. Isaan dhaabbata ispeeshaalistii UK keessatti daa'imman akka nama guddaatti dogoggoraan ilaalaman gargaaraniidha.

Kan nama dhibu namoonni umuriin isaanii waggaa 18 gadi ta'e baay'een UK keessatti akka nama guddaatti dogoggoraan ilaalama. Kun kan dhuunfaa mitii fi waan ati dogoggora hojjette kamiinuu miti. Murtoo waa'ee umurii keetii murtaa'e mormuu yaaluun ni danda'ama.

Stage 1



You arrive in the UK and claim asylum. you tell them you are under 18 as soon as possible. you will be asked how old are you soon after you arrive.

Stage 2



You will have an initial age assessment which means that someone will decide whether or not they think you are under 18 based on how you look and how you act in the interview.

For some people, this assessment will not take place because the Home Office does not think it is needed to confirm your age. If this happens, you will be sent to an accommodation for children and looked after by the local authority.

Option 2: Home Office doesn't believe that you are under 18.

Option 1: Home Office believes that you are under 18.



You will be treated as **Adult and sent to an adult accommodation** such as hotel or camp.. You should try to call a lawyer or Humans For Rights Network to help you appeal this decision as soon as possible. you should also tell staff in your accommodation or a doctor if you are able to see one.

Stage 3



You will be referred to the **local authority** who will treat you as unaccompanied asylum seeking child. the local authority are also allowed to say that it doesn't think you are a child and conduct an Age Assessment.

Option 2: The local Authority doesn't believe that you are under 18 and conduct an age assessment

Option 1: The Local Authority believes that you are under 18.
